N' Between Dreams (NBD) is an association limited by guarantee. As such, it has members rather than shareholders, who are each entitled to:

- Receive a copy of the company's annual accounts;
- Attend general meetings and cast a vote;
- Elect members to the NBD Board by voting at the members' meeting; and
- Vote on any significant changes to the Association, its purpose, its name or how any profit is applied.

N' Between Dreams was formed to assist/prepare young people for their sports/education/career goals while positively contributing to the community in which they live.

The objects for which the Association is established is attached to this letter of invitation.

Any profit made by the association will be retained as a contribution towards the cost of activities in future years. You will not, therefore, be entitled to receive any dividend or other distribution from the company, including if the company is wound up.

The association's constitution is contained in the Articles of Association. A copy of the Articles is available on request.

If the Association is wound up, the maximum you commit to paying towards the Association's debts is CI\$1. This is the guarantee you would make upon becoming a member, as described in the Articles of Association, and applies for the time you are a member and 12 months thereafter.

If you wish to apply for membership, you should complete, sign and date the enclosed Application Form and return it to the above address *with payment of the first subscription fee*.

As a new association, we will be electing the following from our membership for the Board: Treasurer, Secretary, two Event Coordinators and a maximum of seven (7) other members. Please advise in your application if you would be interested in being part of the Board.

I accept that there are risks of personal accident and injury or loss involved in basketball, and in joining the Association I shall voluntarily submit to such risks when participating in training races or other events inspired, organised or administered by the Association and I agree that the Association shall not be responsible for any loss, damage, injury or death that I may suffer while playing basketball.

MEMBERSHIP OF N' BETWEEN DREAMS (NBD)

Members

The Articles of Association of N' Between Dreams, also referred to as NBD, allows for the following classes of membership: Ordinary Member (over 18 years of age), Family Member, Affiliated Member, Junior Member and Corporate Sponsorship Member.

Ordinary Member shall be open to any person age 18 years or older.

Affiliate Member means an individual who is an umpire, referee, coach or other official who is associated with, or recognised by, the Association but who is not an Ordinary Member.

Family Member means, in respect of a family that has a Family Membership, the following family members: (a) any father or step father, (b) any mother or step mother, (c) any Child or adopted Child, (d) any son or daughter, whether adopted or not, that is a Student, whether living with the family or not. It should be noted that a student is a person who is 16 or over and under the age of 20 and attending full time education.

Junior Member is open to a child (person under the age of 18) with a sponsor who is responsible for any liability incurred by the Junior member who shall not be eligible to any interest of the Association property or funds or to hold office or vote at general meetings.

Corporate Sponsorship Member - Any Corporate entity in the Cayman Islands may on payment of an annual subscription fee to be established from time to time by the NBD Board become a Corporate Sponsor Member of the Association. Each Corporate Member shall have the rights to attend all general meetings of the Association and to exercise all rights and privileges as if he or she were an Ordinary Member of the Association with the exception of voting rights.

Membership Dues and Entrance Fees

The membership dues and entrance fees and the dates for payment thereof, shall initially be set out by the Controller and confirmed at each subsequent Annual General Meeting of the Association by the NBD Board. In case of the lowering of such dues, any excess dues paid shall be refunded, and in case of an increase of such dues, additional payments shall be made within sixty (60) days of such Annual General Meeting or within such other timeframe as set by the Controller from time to time.

The current membership fees are as follows:

Membership is yearly and will expire at the end of the Association year-end unless renewed within the timeframe set forth in sub-paragraph (b) below. Subject to the discretion of the Controller, any Member whose membership dues remain unpaid for a period of six (6) months from (a) the date such Member joins in the case of a new member or (b) from the expiry of the Association year-end in the case of an existing Member, shall be deemed to have forfeited his/her claim to membership and the right and privileges thereof, and his name shall be placed before the NBD Board and shall be removed from the Register of Members.

A Member may withdraw from membership of the Association by giving one (1) months' notice in writing, to end on or before the last day of the Association's year, or his intention to withdraw, and shall then have no further claim, right or privilege in the Association, and his name shall be removed from the Register of Members.

A Member whose membership has been revoked and/or whose name has been removed from the Register of Members may be permitted by the Controller in their discretion to resume membership on the presentation of a new application for membership, supported by such evidence and/or information and/or payment of overdue fees as may be required by the Controller.
